These google forms will be circulated to all the Head of Department and respective academic year coordinator to analyze immunization status of Hepatitis B of medical and paramedical staff as well as undergraduate and postgraduate students admitted each academic year. Responses of google forms will be scrutinized under the supervision of Dr Bela Dave. AMCD recommends Hepatitis B vaccination for all students, medical and paramedical staff. The students who are not vaccinated will be counselled by vaccination incharge to know the reason behind not taking vaccine. After counselling, a list will be formulated of the students who are willing to take vaccine duly signed by vaccination incharge which then will be forwarded to the Dean of AMCD. After verifying the list, it will be forwarded to the Head of Department of Pathology of the affliated medical college i.e. AMCMET Medical College and LG Hospital. AMCD ensures the provision of the above mentioned vaccines for those who are willing to be vaccinated. Vaccination report of the vaccinated students will be obtained.
