


1A. Student Feedback Report 2022-23

- The responses were analyzed in order to take corrective actions to enhance quality and check consistence.



1.NAME OF PROGRAM I AM IN




94% responses were obtained from BDS students and remaining from MDS students.

2. MY CURRENT ACEDEMIC YEAR





3. TIME PROVIDED FOR COMPLETION OF COURSE CURICULUM IS SUFFICIENT




• 80% reported that time provided for completion of course curriculum is sufficient and 20% reported that time provided for completion of course curriculum is not sufficient.

4.FACILITIES PROVIDED IN TERMS OF EDUCATION AIDS/AUDIO VISUAL AIDS ARE ADEQUATE





• 100 % faculties agree that the curriculum is defined in a way to help students to understand the subject


3. CURRICULUM IS SUFFICIENT TO TRAIN STUDENTS TO THE MODERN/ADVANCED DENTAL PRATICE?







Program Completed by you in AMC Dental College




98% have completed their program in BDS from AMC Dental College, 2% have completed their program in MDS from AMC Dental College.


1. Do you feel proud to be associated with AMC Dental college as an Alumni?




- 98% are proud to be associated with AMC Dental College as an alumni, and remaining 2% does not feel proud to be associated with AMC Dental College as an alumni.




- A questionnaire was prepared to make a survey on parameters of AMC Dental College and same was filled by employers.

1. Rate Employee who has studied at AMCDC on basis of general communication skills?





3. Rate AMCDC Employee's Clinical Knowledge/Skill?








- The questionnaire was prepared to make a survey on parameters of AMC Dental College and same was filled by the college professionals.

1. How do you rate the curriculum in imparting the human value to the students?




• 64% professionals strongly agree with the curriculum in imparting the human values to the students, 36% professionals agree with the curriculum in imparting the human values to the students.


2. Please rate the achievement of the following learning values through curriculum(ASK)




• 73% professionals rated learning values related to skill as score 5 that is extremely good 27% professionals rated it as score 4 that is good.



• 9% professionals rated learning values related to skill as score 5 that is extremely good 91 % professionals rated it as score 4 that is good.




- 27% professionals rated learning values related to knowledge as score 5 that is extremely good, 73% professionals rated it as score 4 that is good.
